Proposition 218 requires local water districts to notify property owners of any proposed new rates for water services. The Western Hills Water District Board of Directors will consider new rates during the public hearing listed below. This notice also provides information on the reason for the rate increases and what the District plans on doing with the additional revenue generated.

Water and sewer increases will be considered and adopted separately. At the public hearing, the Board of Director will consider sewer rates first and water rates second.

HOW TO PROTEST PROPOSED RATES

Under Proposition 218, the owner of record for a parcel(s) that is subject to the proposed rate increase can submit a written protest against the proposed rate increase to the District at or before the time set for the public hearing. One protest per parcel without regard to parcel value or size. If a majority of the affected parcels submit written protests, the proposed rate increases will not go into effect.

A valid protest must: (1) be in writing; (2) include the County Assessor's Parcel Number (APN); (3) list the owner name(s);

(4) signed by an owner; and (5) be received at or before the public hearing. If the party signing the protest is not shown on the last equalized assessment roll of Stanislaus County as the owners of the parcels(s), then the protest must include written evidence that such party is the owner of the parcel.

Parcel owners must file a separate written protest for each type of utility rate that he/she is protesting. For example, if you are protesting both water and sewer rate increases, then you must file two separate written protests.

If adopted, the new rates would go into effect on October 1, 2010. For each subsequent fiscal year, the new rates would go into effect on July 1 of each year.

Why are water rates being increased?

The District strives to provide reliable water service to its customers and rate increases are needed to cover increasing operational, administrative and water costs. The District Board of Directors established the current water rates on March 25, 1999 and has kept the rates constant for the last 11 years, except that the Raw Water rate was increased from \$350.00 to \$875.00 per acre-foot on September 1, 2009.

The District is projecting annual customer growth with an additional 500 totally new connections expected by the end of 2019. When new customers and the corresponding additional revenues are included, expenses still exceed revenues; therefore, growth alone will not fully pay for annual expenses.

In 2009, the effective cost to the District for raw water at the District's California Aqueduct turnout was \$558.59 per acre-foot. The raw water then needed to be pumped uphill to Diablo Grande. A substantial portion of the water was used for the golf courses and open space irrigation. The remaining raw water was then treated and delivered mainly to the District's residential customers. The total cost for purchasing, pumping, treating, and delivering the treated water was \$2,055,811 and that total cost is projected to increase to \$3,271,120 by 2018-19. In 2009-10, the District's total cost for treated water exceeded revenues by \$1,208,025 and that revenue shortfall is expected to increase to \$1,987,033 in 2018-19. If water rates are not increased, the cumulative shortfall for water totals \$15,350,204 over a ten year period.

If adopted, the new rates would go into effect on October 1, 2010. For each subsequent fiscal year, the new rates would go into effect on July 1 of each year.

Why are wastewater rates being increased?

The District strives to provide reliable wastewater services to its customers and rate increases are needed to cover increasing City of Patterson wastewater charges to the District and the District's own operational and administrative costs. The District Board of Directors established the current wastewater rates on March 25, 1999 and has kept the rates constant for the last 11 years.

In 2009, the District processed 33.98 million gallons of wastewater. Based on the 2009-10 adopted budget, the District will have \$250,421 in expenditures and \$144,719 in revenues, thus creating an annual shortfall of \$105,702. The District is projecting annual customer growth with an additional 500 totally new connections expected by the end of 2019. When new customers and the corresponding additional revenues are included, expenses still exceed revenues; therefore, growth alone will not fully pay for annual expenses. If rates are not increased, annual shortfalls are expected to increase until 2018-19 when the total annual shortfall will total \$365,354. The cumulative shortfall during the ten (10) fiscal years 2009-19 would total \$2,075,200.

How will the District's rates compare to other cities?

In 2006-07, The State Water Resources Control Board (SWRCB) developed a survey of wastewater rates for a typical single family residence located in a city with a population of less than 1,000 and found the following: the highest monthly wastewater charge was \$231.92 (2005), the average charge was \$43.11 (2005), and the median charge was \$33.58 (2005). Although the SWRCB has not updated their survey, the following is a sample of some of the cities in the survey and some of the updated charges:
