- Roll Call of Closed Session 10:00 a.m. adjourned at 11:40 a.m.

 - A. A resident made a comment that WHWD needs to pursue legal action against World International and Angels Crossing.

 - A. Director Kovich to present water source options and discuss termination

of water service to the Diablo Grande community, and potential action relating to the Kern County Water Agency provided termination notice to Western Hills Water District scheduled for June 30, 2025.

Non-Agenda Public Comments

Several residents provided public comment and asked questions about the following topics:

- a. Can the District contact a State Emergency Department
- b. Can the District sell CFD property to pay debt to KCWA
- c. A resident said that whatever homes had been constructed since World Int'l acquired the DG development that the homes that were constructed were done by DR Horton and not World Int'l
- d. What is the Frog Pond. Director Kovich explained.
- e. Can WHWD file bankruptcy and why not have the HOA give financial help to WHWD
- f. Builder DR Horton did not disclose WHWD financial problems
- g. Can WHWD cut employee pay to help pay KCWA
- h. What is the status of the WHWD lawsuits against World and Angels. Attorney Neasham updated the Community on its status.
- i. Resident concern on how the District is managing its business operations to save costs
- j. Residents have interest in bringing in their own source of water and to disconnect service with WHWD
- k. Residents have disclosed they are reaching directly to State officials
- I. Director Kovich showed the March 21, 2021, rate study showing the WHWD rate should have averaged \$500 a month not considering the City of Patterson sewer bill
- B. Resolution 2025-03 Diablo Grande Community Facilities District No. 1 approving transfer of real property to West Stanislaus County Fire District: Motion to approve by M. Kovich, 2nd by M. George Johnson, unanimously approved.
